- > **EPR:** Ethics and Professional Responsibility. This is the amount that qualifies for the EPR component. Do not add this number with the CLE hour(s).
- > **GALm:** Guardian Ad Litem For A Minor. This is the amount that qualifies for the GALm component. Do not add this number to the CLE hour(s).
- > **GALa:** Guardian Ad Litem For An Adult. This is the amount that qualifies for the GALa component. Do not add this number to the CLE hour(s).
- > **GALf:** Guardian ad Litem-Family. This is the amount that qualifies for the GALf component. Do not add this number to the CLE hour(s).
- > **LAU:** Lawyer Awareness and Understanding. This is the amount that qualifies for the LAU component. Do not add this number to the CLE hour(s).
- > **LPM:** Law Practice Management. This is the amount that qualifies for the LPM component. Do not add this number to the CLE hour(s).
