As a reminder, North Carolina requires 2 hours of ethics and 10 hours of other approved activities annually; every third year we require one additional hour of ethics credit dealing specifically with attorneys' substance abuse and/or mental health issues. Credit is based on a 60-minute hour. Activities that are primarily social in nature are not approved.

As a sponsor of this program, you are reminded of your obligation to transmit to the Board, within 30 days after your presentation, an alphabetical list of North Carolina lawyers, with state bar numbers, in attendance; you should also submit any changes in content, faculty or timing that differ substantially from those previously submitted.

Payment of the North Carolina State Bar processing fee should accompany attendance reports. Sponsor does not pay fee when approved activities are offered without charge to attendees and/or when the sponsor is headquartered outside North Carolina and the event is held outside North Carolina. In the latter cases, payment of fee by sponsor is optional. The fee is \$3.00 per credit hour per attorney. Example: 6 hour class x \$3.00 = \$18.00 per attorney x 7 attorneys = \$126.00.
